The second supervisor commits himself/herself to be available as a contact person in case of problems in the doctoral process

The mentor

The mentor is obligated to advise the doctoral student on questions of a multidisciplinary nature.

- 3. The supervison agreement can be cancelled if there is no prospect that the dissertation can be successfully completed within a reasonable time.
- 4. The supervison agreement may be terminated in case of deception in the preparation of doctoral thesis or in the submission oft he required documents.
- 5. Prior to an intended dissolution, the person concerned must be heard. The dissolution leads to the withdrawal of acceptance as a doctoral candiate by the faculty council.
